New NVOCC Rules Take Effect Wednesday 8/22



FMC says amendments to regulations governing NRAs and NSAs aim to make them more attractive to shippers and carriers. The Federal Maritime Commission said its new rules on NVOCC negotiated rate arrangements (NRAs) and NVOCC service arrangements (NSAs) will go into force Wednesday.

The FMC said the changes will allow NRAs to be amended at any time, allow the inclusion of non-rate economic terms and allow an NVOCC to provide for shipper’s acceptance of the NRA by booking a shipment. To read the full story, click [here!](#)
