UN Project Handled on Chartered Vessel

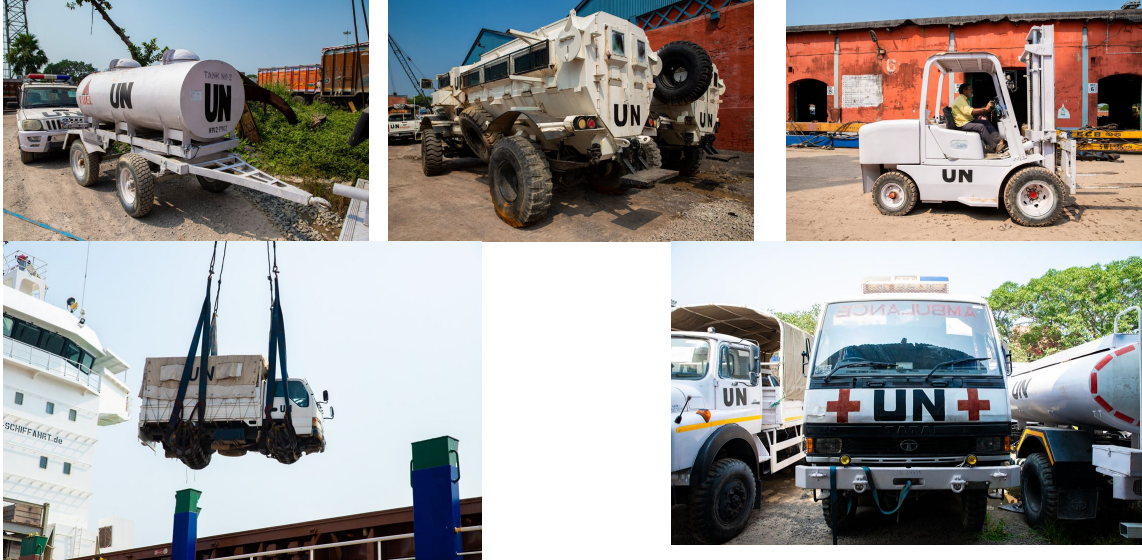

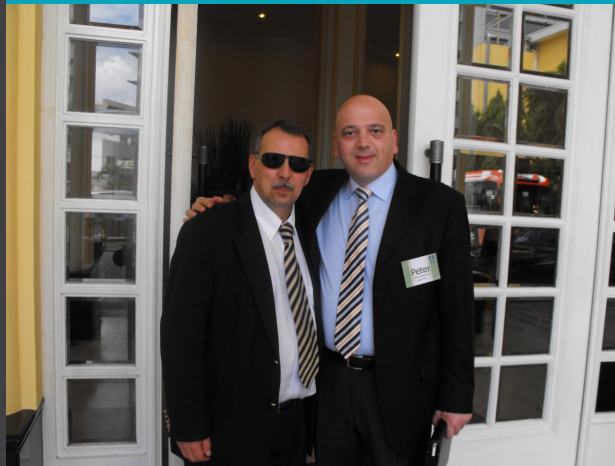
